MOTION FOR EX-PARTE INTERIM ORDER

Restraining both parties from harassing, molesting, threatening, vilifying the other party or the child(ren) in person, by agent or by telephone during the pendency of this proceeding.

11. **Other.** For such other and further relief as the Court may deem just, fair, and equitable.
