MOTION TO RELOCATE

CIVIL No.

[Plaintiff / Defendant] [client name] hereby moves the court for an Order providing as follows:

1. Granting [Plaintiff / Defendant] permission to move to,
 with the minor child[ren] of the parties;
2. Amending Paragraph of the Judgment to read as follows:

Parenting Responsibility. shall be awarded the primary parenting responsibility of the minor child[ren] [name[s]], subject to reasonable parenting time by At a minimum, shall have parenting time on alternating weekends from Friday at 8:00 p.m. through Sunday at 5:00 p.m. The parties shall meet in, on Friday evening and Sunday afternoon to exchange the minor child[ren] .

During the summer, the parenting time schedule shall be as follows: Each parent shall have two (2) weeks of uninterrupted summer parenting time with the minor child[ren], to be noticed thirty (30) days in advance. [When reaches the age of (...), shall have four (4) weeks of summer parenting time to be noticed thirty (30) days in advance. When reaches the age of (...), shall have six (6) weeks of summer parenting time to be noticed thirty (30) days in advance and taken sometime between one week after school lets out until one week prior to commencement of the fall term.] shall be given alternating weekends during the exercise of’s summer parenting time in excess of two (2) weeks. The parties shall meet in, to exchange the minor child[ren] for all summer parenting time.

The parties shall alternate holidays with the minor child[ren] on the following schedule:

and so forth. Memorial Day and Labor Day shall commence on Friday evening and end on Monday evening. Thanksgiving shall commence on Wednesday evening and end on Sunday evening. The 4th of July shall include the weekend if it falls on a Friday, Saturday, Sunday or Monday. Easter shall commence on Friday evening and end on Sunday evening. The child[ren]’s Christmas school vacation (or the equivalent if the child[ren] [is / are] not in school) shall be divided in half. The parties shall alternate the front one-half and back one-half of the child[ren]’s Christmas holiday vacation from school out to the day prior to school commencing. The second half shall begin mid-way through the vacation at noon. The child[ren] shall be with on Mother’s Day weekend and shall be with on Father’s Day weekend. Holiday parenting time shall take precedence over regularly-scheduled parenting time. In the event that a holiday parenting time falls on the other parent’s regularly-scheduled weekend, the parent with the regularly-scheduled weekend shall have the child[ren] on the weekend following the holiday and the alternating weekend schedule shall thus continue, such that no parent shall go more than two weeks without a weekend parenting time.

Each party shall have the right to reasonable communication by telephone and e-mail with the minor child[ren] at reasonable times and at any other time on an emergency basis. The child[ren] shall always be permitted to call or e-mail either parent at reasonable times and in emergencies. All calls left on answering machines or voice messaging shall be returned promptly. Phone numbers, e-mail addresses and residential addresses shall never be withheld from either party or the minor child[ren] . Each change of a phone number and address shall be promptly (within 24 hours) provided to the other party and the minor child[ren] .

The parties may mutually agree to exchange parenting time at any time for any reason including, but not limited to, family reunions, family weddings, significant anniversaries and Grandparent visitation. Agreement shall not be unreasonably withheld.
