SCHEDULE A - IMPUTED INCOME  
(N.D. Admin. Code 75-02-04.1-07)**

This schedule is for use when employment income must be imputed to the obligor who is unemployed or underemployed. Presumption of underemployment exists if the obligor's gross income from earnings is less than 60% of prevailing amounts earned in the community by persons with similar work history and occupational qualifications, or less than 167 times the federal hourly minimum wage. A source of information for data to use in imputing income is the "Wages for North Dakota Jobs" handbook, a publication by Job Service of North Dakota that contains wage and salary information by region and select cities. The publication is available in hard copy from Job Service at no charge; it may also be accessed on the Job Service website.

**4. Obligor noncooperation in review proceedings:**

In **review** proceedings, if the obligor fails to furnish reliable information on income, income is imputed at great of:

- a. Greatest of 2. a. through c. above, or
- b. Net income when order was entered or last modified plus 10% increase per year.\* -07(08)
